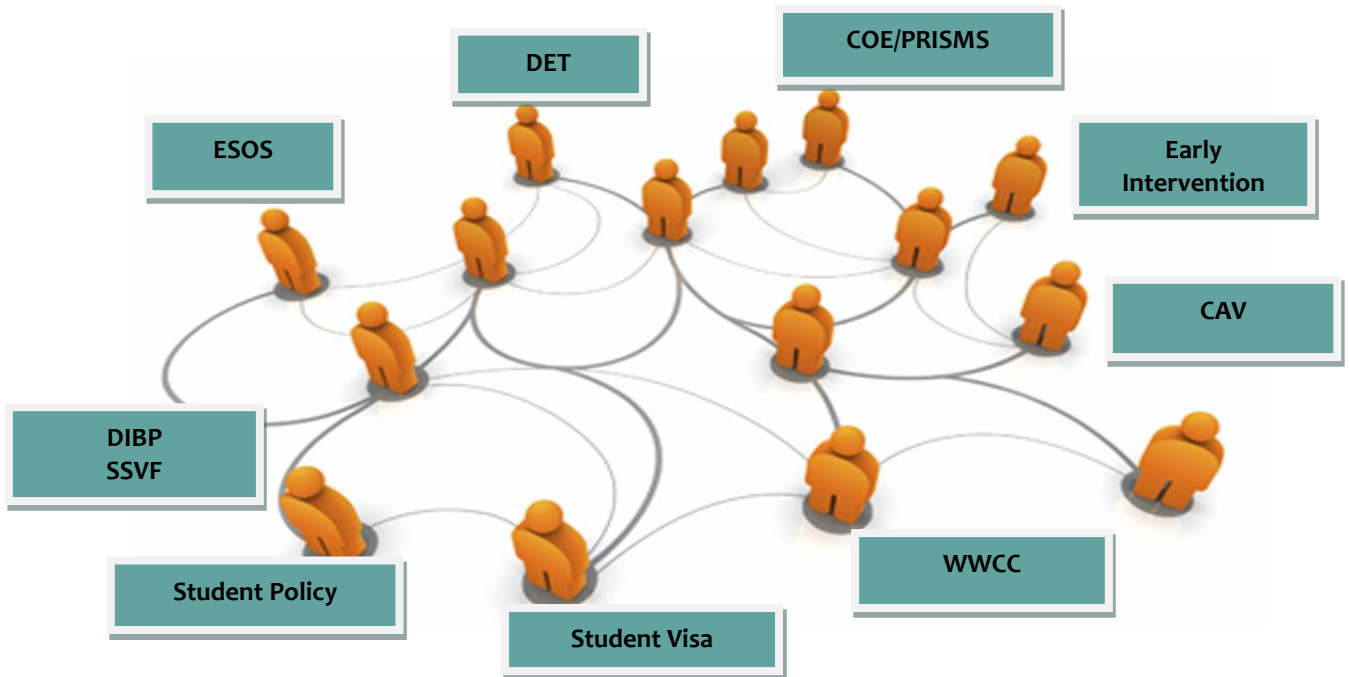


ISANA PROFESSIONAL DEVELOPMENT SESSION ON WHEN THE GOVERNMENT KNOCKS


