YOUR ISANA NZ

ISANA International Education Association of New Zealand Incorporated (ISANA NZ) is a non-profit association focused on the professionalization of the international education sector, the 4th largest export industry in New Zealand.

Our vision is to be the peak body for professionals in the international education industry, supporting them to give international students the best world-class experience in New Zealand and sustain a future proof industry for the country's growth.

ISANA NZ's mission statement is to advocate for international students' wellbeing; provide leadership and integration in the professional network; support industry practitioners and government agencies through referral and pastoral care; as we; as to work closely with NZQA and the International Division on relevant policies and regulations to protect the sustainable growth of the industry.

You are entitled to be a member if you are involved in the education of international students: teachers, coaches, tutors, principals, senior managers, agents, and government body representatives.

Currently there are 196 registered members which went up from 68 in 2019 and a wide network of industry experts who support ISANA NZ in many ways.

MEMBER SUPPORT



- ISANA NZ was the first to offer and successfully delivered an online Micro course on International Student Experience: Orientation, Integration, and Wellbeing to 74 enrolled practitioners.
- Our usual PD days could not go ahead due to COVID-19 but the need for PD and support
 network increased exponentially. ISANA NZ addressed the need of our members as well as the
 need of the entire international education industry by providing a series of 23 Catch-up Cafes
 and 8 Looking Ahead webinars. This has been our flagship initiative in 2020 which has drawn
 significant numbers of participants from across sectors and resulted in the dramatic increase in
 membership.
- ISANA NZ also facilitated meetings with regional managers to provide a platform for sharing best practices, challenges, and networking.
- As ISANA NZ's first and foremost mission is to serve the benefits of our members, we conducted
 a survey to understand more about the challenges they were facing due to COVID-19 and find
 out how we could best assist and support them.
- ISANA NZ is offering \$200 financial support to regional clusters to host an end of year social gathering or add to their already planned end of year event.
- Understanding the industry's need for a consistent and reliable source of information during COVID-19, ISANA NZ employed an effective communication strategy consisting of emails, fortnightly mailouts, and regular social media posts on LinkedIn and Facebook to both our members and non-members. Our website provided a dedicated Sector Recovery Update page and Good Ideas/Resources page which includes responses to support international student wellbeing during lockdown.
- ISANA NZ also spoke to Radio NZ National and appeared on TVNZ Breakfast as well as other news outlet to talk about the impacts of COVID-19 on the export education sector and our members' need for support and clarity from the government.

INTERNATIONAL STUDENT SUPPORT

During lockdown, New Zealand's tertiary sector was faced with strong criticism from NZISA. ISANA NZ played a critical role in mediating and assisting NZISA in advocating for student wellbeing with MOE and other relevant peak bodies.

WORK WITH MOE AND OTHER PEAK BODIES

ISANA NZ is represented at regular meetings with MOE and ENZ. Chris participates in the International Education Recovery -border and has met with Minister Hipkins over Zoom. We have formed deeper connections and trust with peak body leaders. ISANA NZ is now engaged in the government agency/peak body decision making and recognised as a key source of "on the ground knowledge" across the sector as well as expertise in the pastoral care of international students.

WORK WITH ISANA AU

Due to COVID-19, the combined ISANA 2020 conference was postponed 2021. ISANA AU is hosting an online conference in December 2020 with the theme of Turning Challenges into Opportunities. Caroline will have a recorded presentation on ISANA NZ's response to COVID-19. Similarly, Chris will also present on a panel discussion.

FINANCIAL STATE



The 2020 budget was set prudently with expectation of minimum income from membership and no income from PD.

We received \$100,000 from MOE for the International Student Wellbeing Funds this year for our continued project since 2019.

Thanks to the excellent work of our executive/admin team, membership income was increased by \$10,000, compared with the previous two years. The micro course also delivered a revenue of \$7,207 for PD.

Unfortunately, we lost the sponsorship from UniCare and SouthernCross this year due to COVID-19 and their change in personnel. Fortunately, Allianz stuck by us. We received \$12,000 from Allianz for our Catch-up cafes and Looking Ahead webinars. We also received \$3,000 from them sponsoring our Online Micro Course.

ISANA NZ has achieved great success and exposure this year on a very economical budget. We will rely on funding from MOE and ENZ as well as sponsorship from the likes of Allianz to continue our momentum in the coming years.

LOOKING AHEAD

As we write this report, we are still waiting for the confirmation of funding from the New Zealand government for upcoming years. We have lobbied and advocated tirelessly for the government to recognise ISANA as a key partner and player for the recovery of the sector and are confident that our efforts will be recognised.

In 2021 ISANA will play a critical role in the government's strategic recovery of the international education sector. We are committed to continue our professionalization efforts to ensure that we both capitalize and retain key people and knowledge that will be the foundation to "building the sector better". ISANA will actively contribute to this strategy by:

- Stabilising the international education sector, by supporting practitioners both dealing with complex student needs and the uncertainty of the current crisis.
- Strengthening the system by contributing to the discussions about ensuring the regulatory settings, policies and practices support the recovery and rebuild. We will ensure that the student experience remains at the center of what practitioners in the international sector do, while supporting practitioners to have the skill, knowledge and support needed to excel in their roles.
- Contribute to the accelerating transformation of the sector, through shared best practice
 events (such as ISANA Cafes, conferences, and webinars), trainings (such as PD and microcredentials) and networking outreach and opportunities that are accessible to practitioners
 across the sector and throughout New Zealand.
- We will also lend our expertise, and that of our members, to government initiatives that seek to: diversify delivery methods and markets, support the international student experience, and foster global citizenship for both domestic and international populations as well as the development of global competence for teachers and educators.



We express our sincere gratitude to all of our ISANA current members, previous ISANA committees, ISANA volunteers, friends of ISANA and anyone who champions, values and makes the activities featured in this Annual Report possible. We look forward to working together with you to make our 2021 plans a reality.

SECRETARIAT REPORT

The main functions of the Secretariat are:

- providing administrative support to the ISANA Executive, Council, and committee members
- facilitating the signing of new members, their approval and access to the Member's Area of website
- liaising closely with the treasurer to gather and collate financial data
- performing routine administrative procedures including:
 - o liaising via email with members
 - o being the first point of contact via phone and email for members
 - o organising and chairing council meetings including the AGM
 - o liaison between board and stakeholders and providers
 - o processing invoices and banking
 - book-keeping using XERO
- maintaining the membership database, the processing of which includes:

The Secretariat has also been heavily involved in professional development this year. The move to online professional development enabled a wider reach allowing members nationwide and international to access the sessions. The secretariat:

- Managed and troubleshooting of attendee queries
- Managed time and content changes
- Opened the PD sessions and provided technical support to the organising committee and presenters for the duration of the sessions

This year saw the release of the National Code Tutorial (NCT) http://www.isana.org.au/national-code-tutorial/. The Secretariat was involved in assisting the project team throughout the planning phase and advising on the best way to manage students from booking through to completion. The secretariat:

- Designed the completion certificate for the NCT
- Established the booking portal for the NCT



- Promotes the NCT via regular member updates, newsletters, the website, and social media posts
- Manages bookings either individually or via group booking forms
- Invoices and receipts payments and manages the bookkeeping using XERO
- Enrols students into the NCT
- Manages students and troubleshoots any queries
- Reports to project committee

The Secretariat also assisted the project team with the EGI project: ESOS for Students http://www.isana.org.au/esosforstudents/. We continue to manage the hosting of this tool on the ISANA website and Moodle. We continue to assist the project team with any questions and concerns.





Opinion
