One of the strengths of ISANA is our structure – we represent members at a national level in both Australia and New Zealand and at a state level through the branches. All of the branches are to be congratulated for their achievements. They organise invaluable professional development opportunities and represent the interests of members at the state government level and state based stakeholders with an interest in supporting international students.

We held two face to face meetings, two constitutionally convened general meetings and one special meeting. The Council keep in regular contact via email and telephone. Most of the work we do for ISANA takes place outside normal office hours as the majority of office bearers have full-time paid positions. All the work we do for ISANA is on a voluntary basis. We believe in what ISANA stands for and have a shared passion for supporting our international students. It is an honour to represent the members of ISANA and to build on the amazing achievements that have taken place over many years.

The International Student Experience

ISANA members have a longstanding understanding and appreciation of the importance of the international student experience. The success of international education is dependent upon international students having a positive experience. International students make a significant contribution to the Australian community. For many years there has been an emphasis on the economic benefits of international education. It is pleasing to see more discussion on the social and cultural benefits, and that by supporting and empowering international students is of great benefit to the sector.

ISANA has always advocated for effective support networks to maximise the benefits not only to the international students but also to the variety of stakeholders in international education and more broadly within the Australian community. Although there has been more attention on this issue we still have a long way to go to better understand the elements of a positive international student experience.

AEI have undertaken a considerable amount of research on the international student experience and a number of sector peak bodies have also contributed to this discussion. ISANA is keen to contribute to these discussions and ISANA International Education Association Inc. – Annual Report 2011

share with stakeholders the wealth of knowledge our member possess through their hands on experience and research over many years.

Conferences

We are starting to see a number of professional conference companies organising conferences on the different aspects of international education. ISANA has been approached to endorse and participate in some of these conferences.

We have endorsed and participated in the 3rd Annual Campus and Student Security Conference held in May and the Building an International Education Strategy Conference held in July. Participation in these conferences provides ISANA with the opportunity to promote the association to an audience who may not have previously heard about out work.

ISANA also presented at the Australian International Education Conference (AIEC) held in October.

Governance

As advised at the last annual general meeting a Constitutional Working Party was established. The responsibility of this group was later expanded to include governance and became known as the Constitutional and Governance Working Party. Advice was obtained from a lawyer with some suggested changes that we needed to make to our constitution to ensure it reflected the requirements of the Incorporated Association Act.

Unfortunately, the two appointed chairs of this working party each resigned because they held the view that their position had been compromised by a member of the working party who persistently diverted attention away from the core business of the working party. This made it very difficult for the working party to function successfully.

As such, Council felt that current membership and structure of the group was not effective and therefore, it was decided to convene a meeting with the working party members who were not on Council and Council members. During the two meetings proposed changes received from the lawyer were considered. Those changes that received unanimous support have been put forward to members at the 2011 annual general meeting.

The working group consisted of four Council members and four ISANA members. We would like to thank members Ann Bell, Denis Sheehan, John Pittendrich and Michael James for their valuable contribution to the working group.

ISANA's governance and constitution still requires a considerable amount of work and should continue to be a priority for the new Council.

Website and Resources

The ISANA website received a new look in 2011. Existing content was transferred to the new site. New resources and items of interest have been added to the site. There is a wealth of knowledge available – we recently received a site map of the content available and there are 880 individual items and links. This is a testament to the valuable work of ISANA over many years and it is important that the valuable research and good practice examples are captured on the site and accessible to members. Further work is required to ensure members can access the information they need.

ISANA released a number of projects that commenced in 2009. These include the *Good Practice Guide to Engaging International Students Outside the Classroom*, the *Education Agents Manual*, the *Parents Guide* and the *Postgraduate, Research and Students with Families Guide*. These resources add to previous projects available on the ISANA website, including the Rainbow Guide and ESOS Online Tutorial. We are grateful to AEI for funding these projects and for their commitment to improving the international student experience.

Government Reviews

In 2011 ISANA prepared submissions to government reviews in areas relating to the international student experience. In January we provided a response to the discussion paper - *Reforming ESOS: Consultations to build a stronger, simpler, smarter framework for international education in Australia.*

ISANA also prepared a submission to the *Knight Review of the Student Visa Program* and issued a media release in response to the final report and recommendations.

We made a decision to comment on those areas that impacted upon the international student experience.

Stakeholder engagement

ISANA continues to maintain and develop relationships with peak bodies and other stakeholders with an interest in supporting international students. It is pleasing to see an increase in the number of community groups that are interested in supporting international students. These include community groups, welfare agencies, local councils and sporting organisations, just to name a few. The working relationship with these organisations is important to maximize the support and opportunities available to our international students.

ISANA has participated in a number of working groups and consultations to a variety of stakeholders wanting to gain an understanding of the complexities of the international students experience. As a member based association, it is important that members share their good work and any concerns they may have. The ISANA voice is a collective voice of all our members and even though we may not always reach consensus on all issues, it is important that we understand the variety of concerns our members may have.

One of the most important partnerships we have is with the Council of International Student of Australia (CISA). The relationship between ISANA and CISA has been strengthened in 2011. We share a common interest in supporting and maximizing the experience of international students. We congratulate CISA for their achievements to date and look forward to further developing our relationship and working together to supporting the interests of international students.

It has been a challenging year for the ISANA Council – our interest has been to support our members and by supporting members we endeavor to provide a positive experience for our international students. Unfortunately, the ISANA Treasurer has attempted to divert our focus away from our main focus by constantly placing numerous diversions to the ISANA Council. The Treasurer refuses to acknowledge that he is working as a member of a team and has continued to represent his personal views rather the views of the ISANA Council. We could have achieved more if it wasn't for the unproductive diversions of the Treasurer who has not only impacted on the effectiveness of this Council. His actions alone have resulted in the resignation of the ISANA secretariat.

We would like to thank Conference Design for the provision of secretariat services. Ben and Tracy, your contributions have exceeded our expectations and we thank you for your valuable contribution and commitment to ISANA.

VICTORIA

In 2011, we will have seen another successful year in the ISANA Victoria Branch. The role of student advisors for international students continues to change. Understanding that resources are limited, but commitment is strong, our branch has continued to adapt to ensure that our members remain at the heart of the professional development that we present. Together we will be able to deliver to the ever-changing needs of the profession and the international student community in Victoria.

In 2010-2011, the number of international students turning to study in Victoria has improved after the turbulent 2009 year, where re-structures were great, negative media surrounding the support and protection of international students was a continuous stream of concerns that affected our work in Victoria. We are seeing greater programs at the institution level, but also greater interaction with external stakeholders such as City councils and other external organizations.

The ISANA Victoria branch chose to provide profession development in a variety of topics in 2011. These included:

- 4th April Mainstreaming International Students Services Dr Helen Forbes Mewett
- 15th June Inclusive Approaches to Intercultural Dialogues Dianne Collett
- 2nd September State Conference: Managing the Here and Now The current reality of the international student experience
- 16th November Mental Health & International Students

The March, June & November professional development sessions were at no cost to ISANA members. The interest has ranged with these topics with approximately 60/40 split between members and non-members attending. It may be time to re-visit the structure of the professional development and perhaps widen the format. However this is certainly dependant on the needs of the ISANA members in Victoria.

The State conference in September was a successful cross-section of topics of interest with various stakeholder input from Government, industry representatives, international student organizations and students themselves. The international student leader's presentations consolidated the support that our members provide to international students. The student's achievements were outstanding and it is clear that Victoria does provide opportunities for international students.

The Mental Health professional development session is a joint initiative with ANZSSA. This is a first of bringing together the experience of both organizations to develop a session that will build on the challenging factors of mental health affecting our international students. We take the opportunity to thank ANZSSA for their assistance and support in developing the program for the forum which has had extensive interest.

Throughout the year the ISANA Victoria branch was asked to send a delegate to a number of discussions relating to the experience of international students in Victoria. I would like to take the opportunity to thank those who took time from their employment to attend various meetings and represent the ISANA Victoria branch.

I would like to acknowledge the ISANA Victoria branch committee for their energy, promotion of the ISANA membership, and commitment to supporting this organization. They are a wonderful team who have always come together to deliver to our membership. They contribute their time, expertise and passion. The Victoria branch continues to foster strong relationships and demonstrates knowledge and experience with the support to international students.

The future plans will continue to develop the network, and needs of a diverse membership base. The success of the organization will always remain with the members. Be involved, provide suggestions and build on the positive outcomes for our international students through outstanding student support initiatives, which provide a personal sense of achievement.

QUEENSLAND

It has been my honour to represent members of ISANA as the President of the Queensland Branch for the past two years. It was also my pleasure to work with the very dedicated and professional executive team of Liz Wright (GU), Secretary, Nelson Ng (formally MSIT and now QUT), Treasurer, Lio Lay (QUT), Communications Officer and Shereen Metry (UQ), Vice-President until her resignation due to ill health.

Over the past two years, the Queensland membership has grown and now stands as the second largest in the country, just behind Victoria. Current membership stands at 112. This growth has also seen a diversification with many new members coming from the secondary school sector.

Professional Development

In the first year the committee concentrated efforts on providing relevant professional development opportunities for the members and others. These were aimed at drawing back members to ISANA and providing value at a local level. These workshops included: Safety Issues for International Students; Queensland Rooming Accommodation Legislation; DIAC Changes affecting International Students; Insight into Japanese Students and Mental Health Issues; International Students – Relationships and Sexual Health Issues and Welcome Brisbane and Orientation Programs. Attendance at these PD Sessions ranged from 15 to 40 participants.

This year, with all the best intentions to lead off with some early PD sessions, ISANA QLD members found themselves continually catching up following serious natural disasters with floods throughout Queensland and a cyclone in the North. Many of our campuses, schools, staff and students were affected in some way or other. Our skills in handling critical incidents were put to the test and offers of help were generously provided by ISANA members across Australia.

Subsequently two further professional development sessions were conducted during the year on DIAC Changes affecting International Students and ISANA National Conference Update with Dr Shanton Chang. A session specifically entitled 'Queensland Floods 2011 looking after our students,' was cancelled due to low registrations. The third session for this semester was an update on the Knight Review and implications for our students conducted by Helen Duncan.

One of our aims for 2011 in Professional development was to highlight good practice in our State as there are many examples of this where we can learn from each other. It is hoped that this objective can be realised over the next two years where these examples can be presented as PD sessions.

Communication

Queensland Branch now has a fresh newsletter template where PD sessions, policy changes and updates on student support issues are highlighted. Links are also included to services and resources for staff working in international education and specifically in support roles. Eight issues of the e-newsletter have been sent over the two year period.

We also now have a QLD ISANA Banner for display at ISANA events and for promotional purposes.

Representation

As the peak body for international student support services, ISANA has been represented by the committee members at various forums and working parties over the past two years. Changes in the role of QETI has seen the Queensland Government drop the ball somewhat in the area of student support so that these regular meeting are no longer convened. The Brisbane City Council has also disbanded their taskforce where peak bodies were represented, in favour of a Brisbane Marketing lead committee where organisations like ISANA do not easily fit.

However we have had, through our National ISANA body, a number of opportunities to connect with Federal Government departments and are seen as a respected voice on reviews and senate enquiries.

Queensland Issues

Besides the national issues such as student safety, in recent months Queensland is getting a reputation as a State where government departments are at odds with the government policy to encourage more international student to study in the 'Smart State'. The most recent changes include denial of obstetric care for international students in public hospitals and the introduction of preparatory year fees for children of international students including those on Aid related scholarships. Queensland stands out as the only state in Australia to discriminate in this way. ISANA Queensland members in the University sector have worked across boundaries to encourage university senior management to lobby government. These issues were highlighted to sponsoring bodies and foreign government representatives and ISANA has also worked with CISA to lobby Federal Government ministers to encourage QLD to reconsider these changes.

National ISANA

The QLD Branch President sits on the National Executive of ISANA. Meetings are held once a year in person and the rest of the time via teleconference. The National Executive plays an important role in advocating for students and highlighting student issues to Government. There has also been a lot of work done in 2011 to reform some previously loose procedures in the national organisation. We have some dedicated and highly effective officers in the National Executive who have been somewhat hampered in their ISANA work because of lingering issues from a previous period. We all look forward to a resolution to these.

Conclusion

As the term of this committee comes to an end, I think we have achieved quite a bit while we also go about our very busy jobs of supporting international students. I look forward to seeing the further development of the QLD Chapter in 2012 and will be pleased to play an active role as Past-President over the next two years.

I welcome the new committee for ISANA QLD who will hold office for the next two years.

NEW ZEALAND

The past year has been another busy one for ISANA New Zealand, and the international education sector in general. The terrible earthquakes in Christchurch has had a profound impact on not only education providers in that city, but throughout the country. Tragically a number of international students were killed during the February 23 earthquake, most of whom were enrolled in a language school in the centre of the city.

ISANA New Zealand did what it could to support our colleagues directly impacted by the earthquake, though naturally it never feels enough. As an organisation we see our role as ongoing and we are planning to hold a social event in December for our members in Christchurch.

This year we held our conference earlier than usual due to the wonderful Rugby World Cup that was to take over our country for six weeks in September and October. Our conference was held in Auckland at the Waipuna Lodge conference centre, a very good venue overlooking a lagoon but situated in the middle of the greater Auckland area.

Due to all the major incidents that had happened in New Zealand (and the rest of the world) at the beginning of the year our theme was "When Bad Stuff Happens" and looked and reflected on how people managed, coped and survived during these hard times and what lessons could be learned and imparted to the rest of us from the experiences of those that had gone through these major incidents. Unfortunately some of our members got caught up in an incident that was most unpredictable (the Ash cloud from an erupting volcano in Chile) and not all could attend.

It was extremely humbling to hear the tales, trials and tribulations and heartache that people had suffered and how they had managed and adapted and tried to move on again. Some great insights into how you make things work for the people that you are responsible for, while they are at your institution, and how to manage when there is nothing left standing or in such bad shape that it is unliveable or unworkable.

ISANA New Zealand continued to work with various Government agencies on behalf of members and the students that we all work so hard to support. In particular our efforts were directed towards Immigration New Zealand and the Code Office (now named Pastoral Care Office) and Education New Zealand, a Crown Agency recently restructured.

As an organisation we have spent time addressing our constitutional and organisational status, especially in relation to tax issues. While this has proven to be a more lengthy and complex process than initially expected, it has been an important exercise to carefully work through. We expect to have this completed during the first half of 2012.

Sylvia Hooker stepped down as President of ISANA New Zealand at the AGM in June. Sylvia has been a tireless worker and advocate for not only students who choose to study in New Zealand, but also those of us practitioners at the 'coal face'. In following Sylvia in the role of President of ISANA New Zealand I feel incredibly privileged, and deeply indebted to her for all that she has done for the organisation. It is reassuring to know that Sylvia has agreed to remain actively involved with ISANA, and will continue to play an important part within the organisation.

Can I also take this opportunity to thank those organisations who sponsored ISANA New Zealand during the past year; Southern Cross, Uni-Care, Marsh / Vero, ISMNZ and Massey University. Their generous support was instrumental in our ability to deliver the Conference at what was a competitive price.

It is also important that I acknowledge the work the executive of ISANA New Zealand undertake as volunteers, their willingness to put up their hand and agree to take on these responsibilities is to be commended. I would also like to thank Claire Hastings, the ISANA New Zealand Administrator and Terry McGrath, our Vice President, for all that they have done over the last 12 months.

The ISANA NSW Committee has undergone various significant changes this year, with 2011 seeing existing President, Peter Komsta, stepping down, and a new Committee elected at the AGM on 3 May 2011. Stephen Howlett enthusiastically accepted to take on the challenging role of ISANA NSW Branch President but unfortunately, was unable to continue in this role from October 2011. The NSW Branch President and Treasurer positions still remain vacant, however, the remaining Committee members are keen to undertake additional tasks and continue to pursue the needs of its membership.

A chronological account of ISANA NSW Branch activities during 2011 is as follows:

ISANA NSW AGM - 3 May 2011

The ISANA NSW Branch AGM was well attended and saw Stephen Howlett elected as President and myself appointed to the role of Vice President. Stephen and I were welcomed to the Committee. Various DIAC representatives from the Student Processing area and Student Integrity Unit were also present. They provided an update on DIAC procedures and best practice regarding visa application lodgment and PRISMS reporting and allowed members a valuable opportunity to seek clarification on pressing visa-related issues.

ISANA NSW BRANCH EXECUTIVE COMMITTEE MEETING - 4 August 2011

The new ISANA NSW Executive Committee met for the first time on 4 August 2011 to discuss its future directions. The Committee agreed to establish a stronger presence amongst its membership by delivering a range of Professional Development (PD) events in 2011-2012. It was decided that at least one PD event will be arranged prior to the 2011 Annual ISANA Conference in Hobart to introduce the new NSW Committee to the membership and seek feedback. It was suggested that a Mental Health workshop be delivered, however, it was later decided to run this PD event in 2012 for those who were unable to attend the 2011 pre-Conference workshop 'Responding to Mental Health Issues for International Students' in Hobart later this month. The Committee also agreed to sponsor a NSW delegate to attend the 2011 Annual ISANA Conference in Hobart.

ISANA NSW BRANCH PD EVENT: Lessons From The Arab Spring - 23 September 2011

The first NSW Branch PD event of 2011 was well attended with in excess of 20 participants. The event was free of charge and held at the Centre for English Teaching, University of Sydney. Special guest speaker Arfa Noor, President of the Council of International Students (CISA) discussed the role of CISA and the recent learning on current international student issues that arose from the DEEWR International Student Roundtable. I also delivered a presentation on the University of Wollongong and UOW College's Libyan Student Experience as host to the largest cohort of Libyan students in Australia and discussed the Libyan crisis' impact on students and corresponding responses from key stakeholders. The winner of the ISANA NSW Scholarship was also announced – congratulations to Kirsten Saur! Thank you to all applicants – the Committee had a difficult time in determining a winner amongst so many worthy applicants.

2011 and Beyond...

The ISANA NSW Committee has recently drafted a short survey for its membership and other NSW-based Conference delegates to assist ISANA NSW Branch to develop a Professional Development package to suit the needs of its membership in 2012. The survey will be distributed and collected at the 2011 Annual ISANA Conference in Hobart later this month.
